**Markets:**

**Event areas:** Entryway, Museum hallway, Museum room, Board room, Outside-tent space - (tent space is available outside even during winter markets and weather conditions are the sole concern of the vendor. Replacement space will be provided inside on a case by case basis in the event weather conditions prohibit the use of a tent outside).

Note: Event areas are not guaranteed, they are on a first come basis, but we do the best to accommodate all needs. Event traffic will be directed through all areas, and the incorporation of tools such as passport and/or scavenger hunt, door prizes and giveaways will be utilized at each event to drive customers to all vendors.

**OPTION 1:**

**Inside:** Room for (1) 6ft table provided by vendor. \$75/monthly event;

Book 3 markets in advance starting with the next available Saturday market and pay \$62.50/month = Total of \$187.50

Book 5 markets in advance starting with the next available Saturday market and pay \$50/month = Total of \$250.

If you need a table, a \$50 fee will get you a table for all future indoor markets in 2018.

**OPTION 2:**

**Outside:** Room for (1) 10x10 to 12x12 tent \$100/monthly event – Larger tents require an up-charge of \$50 per event.

Book 3 markets starting with the next available Saturday market and pay \$87.50/month = Total of \$262.50. There is no limit to table sizes.

Book 5 markets starting with the next available Saturday market and pay \$75/month = Total of \$375. There is no limit to table sizes.
